## Long-time Arkansas State Chamber Leader, Bob Lamb Passed Away.

**Bob was a founding member of ASAE.**

Bob Lamb, who as the longtime head of the Arkansas State Chamber of Commerce, played a pivotal role in hundreds of economic development projects throughout the state, died Saturday, October 25.

For 25 years, Lamb held the position of Executive Vice President of the Arkansas State Chamber of Commerce and

Associated Industries of Arkansas. In that position, he served as a strong and effective voice for business interests at the State Capitol, led several successful efforts to keep Arkansas a right-to-work state, and organized and led hundreds of industrial job recruitment trips around the nation.

After leaving the State Chamber, Lamb and his wife, DeeDee, moved from Little Rock to Fayetteville, where he worked another 18 years as an officer and director for the Arkansas Western Gas Company.

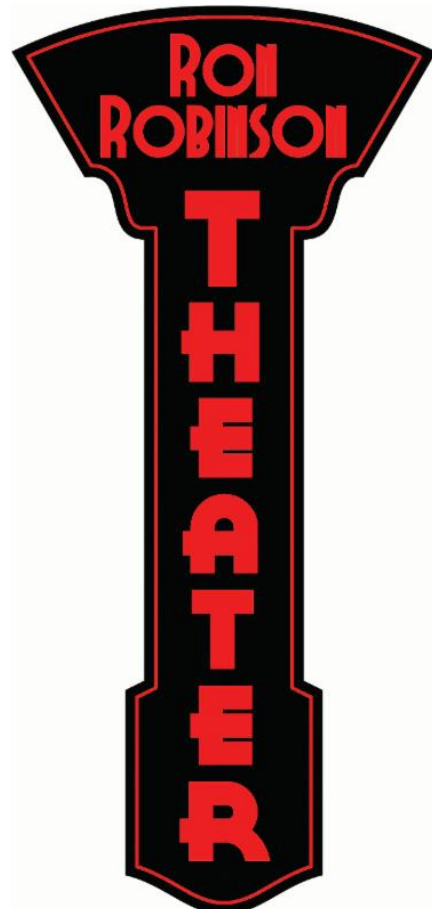

The groundbreaking for the U.S. Marshals Museum was September 24. Fort Smith was chosen as its home because of its storied history with the longstanding law enforcement agency. The groundbreaking launches the first phase of the project, which includes architectural and exhibit design and site preparation. This date also marks the 225th anniversary of the U.S. Marshals Service, the nation's oldest federal law enforcement agency.
